## **THE MISSION**

**BAITUL MAL INC., B.M.I. INC.** was formed to meet the increasing needs of the Muslim community in North America for Islamically based and economically sound investment activities. The company carefully adheres to the rules of Sharia in its dealings and at the same time follows the sound rules of investment.

## **THE OBJECTIVES**

## **DEFINITIONS**

### **Gross Domestic Product (GDP)**

### **Gross National Product (GNP)**

The total value of final goods and services produced both from within a given country and from external (foreign) transactions in a given year.

### **Per Capita Output**

GNP of a country divided by the country's population. It is sometimes used to indicate the relative standard of living of a nation.

### **Price Index**

Device for measuring the changing value of money over a given period.

### **Foreign Debt**

Financial obligation toward foreign creditors.

### **Public Debt**

The current outstanding debt of all periods of maturity for which the central government and its organs are obligated.

### **Balance of Trade**

The net difference between the value of the exports and imports of a country.
